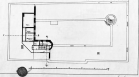


Figure 3: A detailed architectural floor plan of a building. The plan shows a large rectangular footprint with a complex internal layout. On the left side, there is a series of rooms, including what appears to be a kitchen and a living area. A large circular feature, possibly a courtyard or a large room, is located on the right side. The plan is labeled 'Figure 3' and 'A detailed architectural floor plan of a building'.

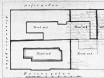

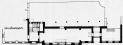

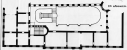
Figure 1. The basic structure of the proposed model.
